Presentation Topics:

While all proposals and topics will be considered, there are a few themes that are always of interest, as well as emerging contemporary themes.

- Truth and Reconciliation and supporting Indigenous learners, employees, and employers.
- Sexual misconduct and abuse, roles, and responsibilities of educators.
- Gender identity and expression, accommodations and needs of students, staff, parent.
- Recruitment and retention challenges and opportunities in education.
- Workplace violence and harassment in education settings.
- Immigration and access to public schools.
- Student issues, including collective and individual rights, students with special needs.
- Charter rights of students, educators, and parents.
- Governance issues.
- Legal issues related to technology in education.
- AI, Chat GBT.
- Competing interests of teachers and other education workers, students, parents, funders, policy makers, communities, and other education stakeholders.
- Schools as workplaces: collective bargaining, duty to accommodate, health and safety.

In keeping with CAPSLE's mandate, we strongly encourage presenters to submit joint or panel presentations which will provide, for example, both union and management perspectives on any given topic. We also welcome submissions in either English or French, as well as those with a focus on post-secondary education.
